I expressly release and discharge the Leprechaun Days Committee and the City of Rosemount, and their agents, officers, and employees, from any such claims, injuries, or damages.

If I am signing this Release and Waiver on behalf of my minor child or ward, I understand and agree that this Release and Waiver releases and discharges the Leprechaun Days Committee and the City of Rosemount, and their agents, officers, and employees from any claims, injuries, or damages that might be suffered by my child or ward. I further agree to indemnify and hold harmless the Leprechaun Days Committee and the City of Rosemount, and their agents, officers and employees for any expenses and liability they may incur as the result of the participation of my child or ward in the parade and related activities.
